In accordance with Article 108. Public Procurement Law (“Official Bulletin of the Republic of Serbia” 124/12, 14/15 and 68/15 ) and in accordance with Report on expert evaluation of bids no. 25-0206-1, director of Anti-Doping Agency of Serbia adopted the following

**DECISION ON**  
**Awarding the Contract**  
**for public procurement of services in open procedure**  
**Laboratory doping control analysis, Analysis of Blood and Urine of athletes in**  
**Laboratory accredited by the World Anti-Doping Agency, PP number 1.2.2/2020**

The Contract for public procurement of services – Laboratory doping control analysis, Analysis of Blood and Urine of athletes in Laboratory accredited by the World Anti-Doping Agency, PP number 1.2.2/2020, awarded to the bidder Seibersdorf Labor GmbH, A-2444 Seibersdorf, Austria in value up to 19.602.000 dinars without Tax.

This decision has to be published on Public Procurement Portal and website of Anti-Doping Agency of Serbia within three days from the date of decision

**E x p l a n a t i o n**

1. On 3.1.2020, The Contract Authority adopted Decision No. 25-0103-1 and launched in open procedure public procurement of services – Laboratory doping control analysis, Analysis of Blood and Urine of athletes in Laboratory accredited by the World Anti-Doping Agency, PP number 1.2.2/2020.

2. Invitation to submit bids no. 25-0106-2, Contract Authority published on Public Procurement Portal as well as on the Contract Authority’s website on 6.1.2020. Also, Invitation is published on Portal of Official Bulletins of the Republic of Serbia and Legislation Databases, in accordance with article 55. paragraph 1. item 2., article 57. and article 60 paragraph 1. item 1. of Public Procurement Law.

3 The public bid opening was conducted on 5.2.2020. in the premises of the Anti-Doping Agency of Serbia, Belgrade, Trg Republike 3, starting at 15.00 hours, in the presence of the Public Procurement Commission, appointed by Decision on Public Procurement Commission no. 25-0103-2 from 3.1.2020.

4. After bid opening procedure, Commission issued Report on expert evaluation of bids no. 25-0206-1 from 6.2.2020 and stated following:

- Subject of public procurement: Laboratory doping control analysis, Analysis of Blood and Urine of athletes in Laboratory accredited by the World Anti-Doping Agency.

- The estimated value of the procurement: 19.602.000 dinars (excluding VAT) .
- Total bids: 1
- Timely submitted bids:

- Untimely submitted bids: none
- Rejected bids, the reasons for refusal and prices: none
- Criteria for Contract Award is "lowest price offered". Given that the scope of these services cannot be accurately determined, the Contract Authority has pre-determined the maximum value of the contract, while the value of the Bid is the sum of unit prices. Such total value represents the basis for applying the "lowest price offered" criterion and serves for the evaluation of bids on this basis.
- Based on the criteria for awarding the contract, the Commission has ranked acceptable bids:

- The Name of most favorable bidder: Seibersdorf Labor GmbH, A-2444 Seibersdorf, Austria

5. After review and expert evaluation of bids, the Procurement Commission proposes a decision on awarding the contract in favor of the bidder: Seibersdorf Labor GmbH, A-2444 Seibersdorf, Austria for bid no 25-0123-1 from 23.1.2020.

6. Given the above, the Director accepted the proposal of the Commission for public procurement, and on the basis of legal authority, bringing the contract award decision cited above.

***Legal remedy: Against this decision, a request for the protection of rights may be submitted to the Contract Authority, within 10 days of publication of decision on Public Procurement Portal. The request shall be submitted to the Contract Authority and a copy shall be at the same time submitted to the Republic Commission for protection of rights in public***

*procurement procedures. The request for protection of rights must contain the elements prescribed by Article 151 of the Public Procurement Law. The applicant is required to pay a tax at the account of the budget of the Republic of Serbia in the amount prescribed by Article 156 Public Procurement Law. In accordance with Article 112, paragraph 2, item 5 of the Public Procurement Law, the Contract Authority may conclude a public procurement contract. before the expiry of the deadline for applications for the protection of the right .*
