Anti-Doping Agency of Serbia in the 2019. conducted a total of 908 doping control analyses (852 control of athletes – 589 in competition and 263 out of competition; 461 controls in national competitions and 128 controls on International competitions, as well as, 56 control of horses).

In 2019, 8 cases of horse doping in gallop and trot racing were detected. The substances that the horses were positive are phenylbutazone, oxyphenyl; furosemide; omeprazole sulfide; ibuprofen; cannabidiol and cannabidiol acid. Three horses were doping positive at the gallop, causing the Serbian Gallop Federation to fine the horse trainers with a fine of 100,000 dinars, and the heads with a one-month ban on racing and disqualifying results. For five horses that were doping positive in trotting, processes are underway before the Serbian Trot Federation.
