Anti-Doping Agency of Serbia in the 2020. conducted a total of 894 doping control analyses (852 doping control analyses of athletes – 561 in competition (432 controls in national competitions and 129 controls on International competitions) and 291 out of competition; as well as, 42 controls of horses).

In 2020, 5 cases of horse doping in gallop (3) and trot racing (2) were detected. The substances that the horses were positive are cannabidiol acid, caffeine, theophylline, capsaicin, heptaminol and hydroxyethylpromazin sulfoxide.
